Defending human rights in the U.S.

PBI-USA continues advocacy, education and outreach work in defense of human rights across the country.

For the first half of the year, PBI-USA has continued its effort to support the work of the projects—in Colombia, five PBI field Guatemala, Mexico, Indonesia and Nepalby educating the American public and advocating for and with the courageous human rights defenders we accompany. These efforts have included two successful advocacy and educational speaking tours.

In January 2009, PBI Nepal field volunteer, Krystal Mason, originally from Pennsylvania, joined PBI-USA Executive Director, Katherine Hughes-Fraitekh, on a two -week speaking tour across the northeastern, mid-western and eastern U.S., which included presentations and meetings with a variety of schools and universities, peace and justice faith-based groups, partner groups, long-term PBI-USA organizations, and supporters and former field volunteers. It also included extensive meetings and briefings with the US Department of State, United Nations staff and Congressional members human rights policies in the new Obama and staff.

In March 2009. human rights defenders and a PBI field volunteer from the three Latin American PBI projects went on a month-long coordinated speaking tour hosted by PBI-Canada and PBI-USA. The US cities visited included Washington, D.C. and New York City. Tita Radilla, Vice-President of the Association of the Family Members of the Detained, Disappeared, and Victims of Human Rights Violations in Mexico (AFADEM), Gloria Gómez. National President of the Association of the Family Members of the Detained and Disappeared (ASFADDES) in Colombia, and Wiebke Schramm, German PBI field volunteer, representing the Organization to Support an Integrated Sexuality to Confront AIDS (OASIS) (which PBI-Guatemala accompanies) traveled and spoke alongside PBI-USA, PBI Mexico and PBI Colombia staff. The speaking tour entitled, "Institutionalized Injustice and the Struggle domestic work please visit our website.

against Impunity: The Dangerous Work of Human Rights Defenders" focused on the overarching theme of impunity-with a call from the victims and their families for truth, justice, reparation, leading to non-repetition. The issue of impunity affects human rights defenders' worldwide.

PBI is in the final stages of producing a special publication on the theme of impunity and its effects in the five PBI field projects. The special publication is expected to be released in the fall of 2009. In addition to a variety of speaking engagements, the speaking tour focused on high level political advocacy in the US and Canada with a focus on building support for improvement in Administration.

Colombia

volunteers who protect 11 NGOs, individuals and two peace communities in Barrancabermeja, Bogotá, Urabá, and Medellín. Major issues include oppression against Afro-Colombians and indigenous groups, as well as ongoing threats and criminalization of human rights defenders. Colombia now has the largest number of Internally Displaced Persons, IDPs, in the world. In a recent publication, PBI Colombia cites that: "between January 2002 and December 2008, 1,244 indigenous people were murdered, which means that, on average, every 55 hours an indigenous person is killed" in Colombia.

Guatemala

The political and social instability of Guatemala has grown significantly worse with the assassination of Guatemalan lawyer Rodrigo Rosenberg on May 10th, and a subsequent video broadcast in which he accuses high-level government officials of plotting his assassination, including President Álvaro Colom. There is no agreement on the authenticity of the claim fended their members, has been targeted

and groups throughout the country have PBI Colombia currently deploys 35 field mobilized either in opposition or support of the President, making the situation highly unstable. The internationally supported truth and justice commission, CICIG, continues its work to bring perpetrators of political violence to justice, but faces major challenges in the corrupt system. The recent coup in Honduras and implications for the region is also a major concern. Mexico

> Since 2005, PBI has accompanied Tita Radilla, AFADEM. The case of Tita's disappeared father, Rosendo Radilla, was heard July 8 at the Inter-American Court for Human Rights in Costa Rica. PBI was present and is awaiting a decision which could set an important precedent for hundreds of other cases from the 1970s "Dirty War". HRDs that PBI accompanies in the Guerrero region have been severely threatened in recent months after the torture and murder of two leaders of the indigenous group, the Organization for the Future of the Mixteco People (OFPM). Indonesia

The terrorist bombings on July 17 dramatically increased political tension in Jakarta. Two weeks prior, the country held its second peaceful democratic presidential election, returning President Susilo Bambang Yudhoyono to a second term. PBI volunteers continue to accompany HRDs in Papua, one of whom, Theo Hesegem, made his first visit outside of Papua and traveled to the US as part of the International Visitor's Program in March 2009. He met with US government officials and PBI-USA voicing his concerns about the lack of implementation of special autonomy protections for the indigenous Papuans required by national law. Nepal

HRDs struggle to stabilize their new democratic republic created through a peace agreement between the armed resistance and the Nepal monarchy after 10+ years of civil war. The entire process is at risk of collapse, due to the PM's resignation. PBI recently opened an office in the Terai region, an area with high numbers of unresolved disappearances. PBI partners with the Conflict Victim's Committee, a women's organization seeking justice.
